**Description of Amendment:**

Allow for revised pricing from the Bidders who met the initial submission deadline of January 31, 2012 due to a possible addition of a new Waiver and to address questions received from these Bidders:

1. Would all 1,000 additional Members be required to self-direct their services or would those Members be given the option to choose to self-direct or receive services through another model?
