




SoonerCare Home and Community-Based Services (HCBS) Waivers allow the flexibility to develop and implement creative alternatives to safely serve SoonerCare-qualified individuals in a community-based setting other than a long term care facility or an intermediate care facility for the mentally retarded/intellectually disabled (ICF/MR). There are eight HCBS waivers available in Oklahoma: ADvantage, Community, Homeward Bound, In-Home Supports for Children, In-Home Supports for Adults, Medically Fragile, My Life My Choice and Sooner Seniors waivers.

Monthly Total Home and Community-Based Services Waivers Enrollment




Total HCBS Waivers Enrollment Race Breakdown

Program Breakdown by Gender





