


Emergency Department Fast Facts

State Fiscal Year 2016


The Emergency Department (ED) Fast Facts provides a summary of SoonerCare ED visits. This summarizes physician, facility ED charges and overall ED utilization by SoonerCare members. No ancillary or SoonerCare Supplemental (Dual Enrollees) costs are included unless otherwise specified.

The data is an unduplicated count of facility and professional claims. *SoonerCare Members include Insure Oklahoma members.


ED Visits by Location



Race is self-reported by members at the time of enrollment. The multiple race members have selected two or more races. Hispanic is an ethnicity not a race. Hispanics can be of any race and are accounted for in a race category above.

Average ED Cost per Utilizing Member by Age Range




For this report CHILD is defined as an individual age 20 and younger. The greater than 65 age range contains a large percentage of members with both Medicaid and Medicare (SoonerCare Supplemental/Dual Enrollees) coverage. OHCA only pays the co-pay and deductible for SoonerCare Supplemental, which accounts for the relative decline in cost for members 65 and older.

Average ED Cost Per Utilizing Member by Benefit Program


