***SoonerCare 2005 Contracts Due Friday, Dec. 10***

## **Program Changes in 2005**

Two changes in health care delivery necessitated by the implementation of federal Medicaid managed care regulations will be implemented with the 2005 contract. Effective January 1, 2005, all *SoonerCare* members have direct access to family planning services. It is not required that members 18 and older see their PCP/CM or get a referral to see a different provider. The other change is for female members and has the same implementation date. These members will have direct access to women's routine and preventive health care services. No referral from the PCP/CM is required.
